CITY OF GOOSE LAKE CITY COUNCIL MINUTES March 17, 2022

Mayor Ken Schoon called the regular monthly meeting to order at 7:00 pm. Council Members present included: Mike Mattis, Mike Schmidt, Matt Cain, Darrin Farrell, and Josh Spain. M/S, Spain-Schmidt moved to adopt the agenda as presented. On roll call, carried unanimously. Mayor Schoon announced a Public Hearing on the proposed FY 2023 City Budget. There were no comments from Council or audience. M/S, Schmidt-Cain moved to close the Public Hearing. On roll call, carried unanimously. M/S: Farrell-Cain moved to approve the consent agenda. On roll call, carried unanimously. The consent agenda includes minutes of the February 17, 2022 regular meeting, the February 23, 2022 special meeting, the treasurer's report, financial reports, and the following new bills.

Expenses February were General \$3552.20, RUT \$3202.16, County Contributions \$0.00, Local Option Sales Tax \$500.00, ARPA \$0.00, Water \$6717.44, SRF Sinking Fund \$0.00, Water Trust \$0.00, Sewer \$3739.41, Sewer Sinking Fund \$0.00, Garbage \$1980.92. Revenues for February were General \$1699.80, RUT \$1784.41, County Contribution \$3163.34, Local Option Sales Tax \$0.00, ARPA \$0.00, Water \$10219.59, Water Trust \$0.00, SRF Sinking Fund \$3000.00, Sewer \$4008.58, Sewer Sinking Fund \$1500.00 Garbage \$2007.60.

The monthly Sheriff's report was sent in by Sheriff Bill Greenwalt. There were 40:34 total hours logged for the month; 24 calls for service; 1 citations or warnings; 1 case reported. Marty Jahn, Water Operator, sent a report on the Water Department stating the monthly reports and tests have been sent to the DNR. There was one locate and the chlorine pump was rebuilt. Jahn was present to address the Council and the annual water report and asked the City Clerk to add it to the newsletter. There was no report on the Wastewater Department. Fire Chief Kevin Cain reported on the activities for the Fire Department, noting since February 21, 2022 there have been 3 EMS calls, a structure fire, an automobile accident, and 2 training meetings. Chief Cain stated the pumper truck that had just been repaired was not functioning as it should during the last fire they attended. After speaking to the company that last repaired it, a part was needed to be ordered to ensure it will function. The cost is estimated at \$5000.00 to repair. Chief Cain also added the Department is looking into taking over hydrant testing, but would like to purchase a tester to gauge the pressure coming out of the hydrants. Council will discuss this at the April meeting.

There were no other committee reports or maintenance issues. Mayor Schoon stated he will open the park restrooms around Easter time. Judy Buntemeyer addressed the Council and questioned a grant the city received for computer equipment from the State of Iowa through the Cares Act Funding. City Clerk will get her information.

Mayor Schoon stated he received a quote from JJJ Enterprises, Inc. to remove and replace a fire hydrant on Emma Ct., and to repair the fire hydrant on O'Brian Street. The bid did not include any finishing, or seeding of the completed areas, permits or bonding. Total bid price was \$6486.15. M/S: Mattis-Farrell moved to accept the bid from JJJ Enterprises, Inc. for \$6486.15. On roll call, carried unanimously.

M/S: Schmidt-Spain moved to approve Resolution No. 9418 approving the FY 2023 City Budget. On roll call, carried unanimously.

Mayor Ken Schoon proclaimed April 7, 2022 as Junior Achievement Day in Goose Lake, Iowa. Mayor Schoon read the proclamation to the Council.

Mayor Schoon stated he sent an email to Northeast Community School FFA Advisor Joel Frost regarding the termination of the land lease between the city and the school for the ground by the city lagoon. Mayor Schoon offered to have an official termination, however Mr. Joel Frost replied that the email notification was sufficient notice for the lease termination.

M/S: Farrell-Cain moved to adjourn the meeting at 7:24 pm. On roll call, carried unanimously. The next regular meeting will be held on April 21, 2022 at 7:00 pm at City Hall in Goose Lake.
