The monthly Sheriff's report was sent in by Sheriff Bill Greenwalt. There were 49:51 total hours logged for the month; 24 calls for service; 1 citation or warning; 1 case reported.

Water Superintendent Marty Jahn was present with Duane Levein and stated that the water plant is doing good. Booster 2 is setting off an alarm and he will get ahold of TJ Burken to look at it. Jon Ryk with the DNR did an inspection and that went well. Duane talked to Northway Well & Pump to address the conduit that needs replaced and the old well that needs capped off. He also stated that there was an alkalinity problem that led to a lead and copper problem, now that this is resolved, he is hoping the DNR will allow the city to go back to a three-year testing period. Marty and Duane asked for a raise, it will be put on the December agenda. Duane stated that the inside of the tower will eventually need to be inspected.

There was no sewer report.

Assistant Fire Chief Cain said the Fire Department received a grant to purchase a new brush truck. Their Drive-Through Spaghetti Supper Fundraiser will be December 14<sup>th</sup> from 4-7 pm. They had 5 calls and 2 training meetings.

Pat Driscoll is the new contact for the Senior Citizens group.

Councilmember Schmidt met with Tyson Sullivan to put in a water heater in the daycare.

Mayor Schoon winterized the park. Tom Heiar will put up the holiday lights soon.

Recognition of Visitors: Judy & Barry Buntemeyer. They would like their water turned back on and Mayor Schoon said that they need to install the new meter per city ordinance. Judy read a letter to the council.

Council wants to thank Amanda Fowler for giving suggestions for our town looking it's best. We don't have an area for yard waste, but will check with AT Disposal to see if he has a solution.

The city decided to go with bids for mowing instead of hiring a part-time employee. The bids would be for a three-year period and they would need to carry their own liability insurance.

New Generations Learning Center is increasing enrollment. They want to open an infant room soon. If anyone is interested in volunteering in the infant room, please contact Kelcie Tillery.
