Revenues for August were General \$13265.63, RUT \$1724.72, County Contribution \$1347.12, Local Option Sales Tax \$2294.51, ARPA \$16447.52, Capital Projects Fire Sinking Fund \$5000.00, Water \$5891.54, Water Trust \$0.00, SRF Sinking Fund \$0.00, Sewer \$3615.97, Sewer Sinking Fund \$1500.00 Garbage \$250.95.

The monthly Sheriff's report was sent in by Sheriff Bill Greenwalt. There were 39:16 total hours logged for the month; 28 calls for service; 1 citation or warning; 1 case reported. Marty Jahn, Water Operator, sent a report on the Water Department stating the monthly reports and tests have been sent to the DNR. The new meters and supplies have arrived. Fire Chief Kevin Cain sent a report on the activities for the Fire Department; Darrin Farrell presented the report. Farrell stated that since September 15, 2022 there have been 3 EMS calls, 2 training meetings; they participated in a 9-11 tribute at Northeast Football game.

Mayor Schoon stated the Goose Lake Senior Citizen's met for their monthly polluck and card playing. Mayor Schoon stated he caulked the windows and replaced some plywood panels at the city hall building. Mayor Schoon stated there is an ash tree in the park that will need to come down, maybe after the harvest period is over. The trail has been repaired after the large truck that did soil borings for the lagoon project went down and damaged a portion of it.

City Clerk updated the Council on the new metering system and asked for volunteers to have their endpoints installed while testing and software installation are being done. All council members present and the Mayor stated they would have their endpoints installed and if necessary, a new meter put in within the next few weeks.

M/S: Farrell-Spain moved to reimburse Mike Mattis \$1,060.00 for cement and repairs done to his driveway after the water main break on Emma Ct. in front of his house. On roll call: YES – Spain, Schmidt, Farrell. Abstain: Mattis. Motion carried.

M/S: Schmidt-Spain moved to approve the fall clean-up date to be October 1st and 2nd weekend. The dumpster will again be placed in the city hall parking lot. On roll call, carried unanimously.

Mayor Schoon set the up-coming Trick-or-Treat time to be Sunday, October 30th from 3:00 pm to 5:00 pm.

In Other: Mayor Schoon stated he contacted Mannatts, Inc. for obtaining a quote to repair the potholes. We are on the list, but it will not get done until next June or July.

M/S: Farrell-Spain moved to adjourn the meeting at 7:35 pm. On roll call, carried unanimously. The next regular meeting will be held on October 20, 2022 at 7:00 pm at City Hall in Goose Lake.
